Terms and Conditions

- _____ All renters must be the age of majority in the Province of Manitoba, which is 18 years of age.
- _____ All park facilities are closed from 10 pm to 6 am. All rentals end at 10 pm.
- _____ No ALCOHOL anywhere on premises without written approval from the Kleefeld Recreation Board and the appropriate permit.
- _____ No SMOKING anywhere on premises – park, canteen, rec centre, playground, washrooms, rink, etc. E-Cigarettes are not permitted in any building.
- _____ Be responsible for the behavior of any and all guests invited and/or allowed to the function held in/at the rented facility.
- _____ Leave all facilities rented in clean condition: sweep floors, spot mop, wash dishes, wipe & put away tables & chairs, place garbage in barrels
- _____ When leaving, please lock all doors and return all keys immediately.
- _____ Vehicles are not permitted on park grounds or walking path. Vehicle owners will be responsible for any and all associated towing costs.
- _____ Failure to follow the terms and conditions of the Kleefeld Recreation Board can result in rental cancellation and/or refusal of future rentals.
- _____ Any change from these terms and conditions must have written approval from the Kleefeld Rec Board.

I agree for myself and all other persons I permit to use the facilities pursuant to this rental agreement that the Kleefeld Recreational Association Inc. directors and members are not liable for anything that may happen to anyone or anything in or around the rented facility arising out of the rental and the function held.
